

Tufts Health Plan Medicare Preferred Case Management List

Bolded medical groups are “delegated” and non-bolded medical groups are “non-delegated.” The non-delegated Tufts Health Plan Medicare Preferred Case Managers are assigned by medical group and episode of care. In some cases, due to geography, medical group size and / or volume, there may be up to three case managers assigned to each medical group. Each medical group also has a designated primary case manager who can be contacted for member’s who are not presently receiving acute care (AC), extended care (EC) or home care services (HC). In all cases, except groups 135 & 301, the acute care case manager is also the medical group’s primary case manager (PCM).
